NOTIFICATION

In the Department of Women and Child development and Social Welfare under Government of West Bengal, there is 01(one) Departmental Officer, namely District Program Officer (ICDS) with 05(five) support staff to look after various Centrally sponsored schemes like ICDS scheme, SAG and National Crèche Scheme and some other activities of this Department. The District Programme Officer (ICDS) with support staff work under immediate administrative control of the concerned District Magistrate.

In the recent past four new Districts have been formed by way of bifurcation of the districts of Jalpaiguri, Darjeeling, Paschim Medinipur and Bardhaman by this State government. Hence, for implementation and monitoring of the Schemes and activities as indicated above within the newly formed Districts, the Ministry of WCD, Government of India, has sanctioned four District ICDS Cells along with new posts vide Letter No.11-31/2016-CD.I Dated.23th January,2018 keeping parity with existing posts in the other Districts

In order to facilitate the above works of Women& Child Development and Social Welfare Department pertaining to the newly created Paschim Burdwan District created under Notification No.80/AR/O/2R-3/12 Dated.24.03.2017, Jhargram District created under Notification No.79/AR/O/2R-1/2011 Dated.20.03.2017, Alipurduar District created under Notification No.634-PAR(AR)/O/2R-4/12 Dated.20.06.2014 and Kalimpong District created under Notification No.35-PAR(AR)/O/2R-2/16 Dated.07.02.2017, the Governor has been pleased to sanction for i) Setting up of four(04) Districts ICDS Cells in four (04) newly created districts and ii) Creation of **four (04) posts of District Programme Officer(ICDS), four (04) posts of Head Assistant, four (04) posts of Statistical Assistant, four (04) posts of UDA/UDC, four (04) posts of LDA/LDC and four (04) posts of Peon/Group D**, for the said four(4) District ICDS Cells, as follows:

Recruitment against the posts of District Programme Officer (ICDS) & other staff shall be made by the Department and Directorate respectively as the case may be observing the provisions of rules regulating recruitment to the post in force.

The concurrence against the creation of posts as above has been issued by the **Finance Department vide their U.O. No.Group P2/2018-2019/0137 dated.21.05.2018.**

This has also got the approval of the **Cabinet vide No.1000 dated.06.07.2018.**
